Proposal 1.

Take back to groups, regarding the virtual side of the business meeting:

Should the area change the way they conduct their business meetings?

Currently, area provides a hybrid format.

Should area keep the hybrid format? VOTES: Recovery and Chill, OLT, RCM

Should area remove the hybrid format?

Should the area meet virtually only? VOTES: Live from Laramie, Not Alone, Vice Chair, Secretary

Should area meet in-person only?

Or should the area decide?

Reason: To create an atmosphere of unity, if we are all attending the same way, we would feel less disconnected.

-LACK OF STRONG SUPPORT, proposals fail. We will try to revise what we ask the groups.

- Some back story on why hybrid is so difficult:
 - o It is not truly hybrid since someone has to be there to set everything up
 - It is a very stressful responsibility and the secretary was using his own computer and equipment since the Area laptop, which we do not currently have, rarely worked.
 - There were constantly problems with getting Zoom up and running such as internet connectivity issues at depending on the location, sometimes the hardware would not connect properly and that needed to be trouble shot
 - The secretary was showing up to Area meetings 30 minutes early and due to problems with Zoom or the hardware the meeting was still starting late
- After discussion RCM felt that he wants to change his vote to FOR virtual after hearing about the difficulties associated with it
- Spencer, Serenity Seekers GSR felt that he and the group would be in favor of virtual, however they did not vote on it during their group consciousness.
- The alt-GSR for OLT and Recovery and Chill decided to change the vote after hearing about difficulties associated with the hybrid side of things. They felt that with this new information their groups would feel differently
- Tried and True group, non voting group until February, had also decided virtual only
- Chair asked for another roll call: **VOTE**: (yes) Live from Laramie, (yes) Not Alone, (yes) OLT, (yes) recovery and chill, (yes) Vice Chair, (yes) secretary, (yes) RCM
 - -UNANIMOUS, motion passes

Proposal 2.

Changing the area meeting to every other month instead of monthly. **VOTE**: (yes) Live from Laramie, (yes) Not Alone, (no) OLT, (no) recovery and chill, (no) Vice Chair, (no) secretary, (no) RCM

Reason: Lack of participation from groups and committee members.

-LACK OF STRONG SUPPORT, proposal fails

Proposal 3.

Create a schedule of events outside of area business meetings that would be workshops and informational discussions. (a Not Area, Area Meeting) . **VOTE**: (yes) Live from Laramie, (yes) Not Alone, (yes) OLT, (yes) recovery and chill, (yes) Vice Chair, (yes) secretary, (yes) RCM

Reason: To generate interest in area positions and create a sort of mini-learning day.

-UNANIMOUS, motion passes

Proposal 4.

Removing the study portion of the business meeting. (12 Traditions, 12 Concepts) **VOTE**: (yes) Live from Laramie, (yes) Not Alone, (yes) OLT, (yes) recovery and chill, (yes) Vice Chair, (yes) secretary, (yes) RCM Reason: To shorten the length of the business meeting.

-UNANIMOUS, motion passes

Proposal 5.

Pare down services offered in the area. Area offers basic services only, such as the virtual platform for the virtual meetings, the website and maintaining the meeting list. If a group needs something they can contact the area with their request to be considered. Move area meetings to less frequent, to consider requests and give an overview of the area.

Reason: Lack of participation from groups and committee members. **VOTE**: (no) Live from Laramie, (yes) Not Alone, (no) OLT, (no) recovery and chill, (no) Vice Chair, (no) secretary, (no) RCM

-CONSENSUS NOT TO SUPPORT, motion passes

Proposal 6.

Move from Sub-Committee Based Service to Project Based Service. This will remove Sub-Committee Chairs and replace them with Project Leaders / Coordinators.

This will not affect projects already in place, such as school panels and H&I efforts. It just removes them from the PR Umbrella and focuses on the specific project.

It changes the structure of how events are created, planned and put into motion.

Reason: Lack of interest for volunteers and there are too many layers for a PR Chair to monitor over the large demographics of our area. Brings more investment and interest to the groups and individual members to participate.

If we allow members to focus on the specific areas they want to as a project-based service, we could still fill needs in the Area.

Examples:

- Web Servant becomes Web Site Project Coordinator, and reports directly to the area instead of PR.
- School Panel Leader becomes School Panel Project Coordinator and reports directly to the area instead of PR.
- Activities Chair becomes Activities Project Coordinator, does not plan events, but takes requests from groups or individuals who want to create a specific event as a project. The Activities Project Coordinator only brings the request to area and the group or individuals creating the event report to the Activities Project Coordinator.

Current:

An NA group is any meeting which meets regularly at a specific place and time, and which follows the Twelve Traditions of NA. The primary purpose of an NA group is to carry the message of recovery to the addict who still suffers.

Proposed change:

An NA group is any group that meets and follows the suggested requirements stated in the current published version of The Group Booklet. This booklet can be found and downloaded for free at: GroupBooklet_Final_Aug23.indd

Treasurer

The Treasurer will make a report of all the contributions and expenditures at every WBASC meeting as well as an end of term(s) of office report. It is suggested that the WBASC Treasurer have a minimum of three (3) years continuous clean time, has demonstrated a working knowledge of the Twelve Traditions and the Twelve Concepts for NA Service, and presents a history of completed NA service positions, preferably at the area level. It is strongly suggested that waiving clean time for this position be discouraged. (02/12/22)

It is the duty of the WBASC Treasurer to:

- Be the custodian of the WBASC funds
- Maintain a comprehensive ledger that records all transactions and budgets and use the approved spreadsheet as a tool 1/23/22
- Be one of the signers on the WBASC bank account
- Report income and disbursements at each regular WBASC meeting, followed by a written report in the minutes
- All reports should include a reconciling to the bank statement and a copy of that month's statement (02/12/22)
- Disburse funds as directed by the WBASC
- All disbursements must be in check format for tracking purposes
- All persons requesting reimbursements which have been approved must submit receipts before being reimbursed no exceptions (02/12/22)
- A Treasurer shall keep receipts for all contributions and disbursements
- All cash contributions and proceeds from WBASC functions or committees will be deposited to the WBASC bank account within 2 weeks from the function or business meeting
- Automatic disbursements are those expenditures made on a continuous and approved basis by the WBASC (i.e., rent for facility hosting ASC, travel expense for RCMs, P.O. Box and website expenses)
- Checks will be written directly to businesses or those providing services to the WBASC
- There will be one (1) debit card issued to the treasurer and can also be used for the purpose paying for services related to business for the WBASC
- There will be no cash withdrawals from the bank account in order to maintain accurate records of any and all transactions
- All checks received are to be deposited into the WBASC bank account within five (5) working days
- Attend every regular WBASC meeting
- Submit all records, information, forms, and archives to the next Treasurer when term(s) of office is/are done

Current:

Regional Committee Members (RCMs)

The two (2) RCMs are the WBASC's representatives at the regional level. The RCMs link the WBASC with other area service committees within the Upper Rocky Mountain Region. The primary responsibility of the RCMs is to work for the good of the WBASC, providing two-way communication between the WBASC and the rest of NA. They represent the WBASC groups' consciences at the regional level.

The RCMs attend all WBASC and all URMRSC meetings. They take part in any discussions and in all decisions affecting the region, speaking as the voice of the WBASC groups' consciences. It is suggested that the RCM(s) have a minimum of three (3) years clean time, has demonstrated a working knowledge of the Twelve Traditions and the Twelve Concepts for NA Service, and presents a history of completed NA service positions, preferably at the group and area level.

It is the duty of the RCM(s) to:

- Represent the interests of the WBASC at the URMRSC and to carry the WBASC's groups consciences and work for the primary purpose of NA
- Report to the WBASC verbally and in writing the activities of the URMRSC
- Report to the URMRSC verbally and in writing the activities of the WBASC
- Submit a written report of activities of the WBASC as RCM and a copy of the information submitted to the URMRSC at the following WBASC meeting
- Topics sent to region need to be discussed at the WBASC before reporting to region (12/11/21)
- Act as the URMRCNA Liaison, making sure the WBASC is kept up to date on all convention information and efforts of the convention (02/12/22)
- Attend all WBASC meetings, URMRSC meetings and Upper Rocky Mountain Regional Assemblies
- Reimburse travel expenses to regional meetings and assemblies at \$0.35 cents per mile (07/09/2022)
- Will be signers on the WBASC bank account
- Will each serve one two-year cycle, with the option of serving two two-year cycles, thus committing to up to eight years
 and four cycles in total
- The "second" RCM is "in training" for a two-year term and will need to be nominated and voted into the RCM position when the term has been met (12/11/21)
