# Chairpersons Report April 30<sup>th</sup>, 2004

The following is a special "PI/phone-book report" based on a conversation that I had yesterday with Colly Brazil from *Qwest-Dex*. This is a follow-up on an initial call made by Kathleen L., our area secretary at the time, on getting our area infoline number published in the phone books in the Wyo-Braska Area. I am turning this report over to Kathleen who was elected last month as our new PI chair so the committee can take action and come to the next area with a recommendation, although this report will be available to anyone who wishes to see it.

First off. Our last working PI chair, Frank R., did a great job getting this info line set-up. We have a toll-free number for which we are paying \$10 to \$12 dollars a month. The draw back being that our number is not published in any phone book in the Wyo-Braska area. That being said, this is the information I got from Colly. *Qwest-Dex* first off does not have service in Scottsbluff, NE. They do cover the other counties we serve in Nebraska with two phone books and all the counties we cover in Wyoming also with two phone books. The following is a list of prices to get our number put in the yellow pages of each phone book.

The first Nebraska phone book, which covers Banner and Box Butte counties and comes out in February, will cost us \$11.40 per month. The second Nebraska phone book, which is the Sydney phone book and covers Cheyenne County comes out in August and will cost us \$10.50 per month. The first Wyoming phone book, which is the Cheyenne phone book and covers Goshen, Laramie and Platte Counties comes out in March and will cost us \$17.30 per month. The second Wyoming phone book, which is the Laramie phone book and covers Albany County comes out in December and will cost us \$12.40 per month.

To have our number published in the white pages, and these are estimates, it will cost \$3.00 per month per book with a \$12.00 set-up fee. For more information on that we are to call 1-800-603-6000 and ask to get our toll-free number published in the business section. To reach Colly Brazil the number is 1-800-345-1503 extension 1324.

# Chairpersons Report April 30<sup>th</sup>, 2004

The following is a special "PI/phone-book report" based on a conversation that I had yesterday with Colly Brazil from *Qwest-Dex*. This is a follow-up on an initial call made by Kathleen L., our area secretary at the time, on getting our area infoline number published in the phone books in the Wyo-Braska Area. I am turning this report over to Kathleen who was elected last month as our new PI chair so the committee can take action and come to the next area with a recommendation, although this report will be available to anyone who wishes to see it.

First off. Our last working PI chair, Frank R., did a great job getting this info line set-up. We have a toll-free number for which we are paying \$10 to \$12 dollars a month. The draw back being that our number is not published in any phone book in the Wyo-Braska area. That being said, this is the information I got from Colly. *Qwest-Dex* first off does not have service in Scottsbluff, NE. They do cover the other counties we serve in Nebraska with two phone books and all the counties we cover in Wyoming also with two phone books. The following is a list of prices to get our number put in the yellow pages of each phone book.

The first Nebraska phone book, which covers Banner and Box Butte counties and comes out in February, will cost us \$11.40 per month. The second Nebraska phone book, which is the Sydney phone book and covers Cheyenne County comes out in August and will cost us \$10.50 per month. The first Wyoming phone book, which is the Cheyenne phone book and covers Goshen, Laramie and Platte Counties comes out in March and will cost us \$17.30 per month. The second Wyoming phone book, which is the Laramie phone book and covers Albany County comes out in December and will cost us \$12.40 per month.

To have our number published in the white pages, and these are estimates, it will cost \$3.00 per month per book with a \$12.00 set-up fee. For more information on that we are to call 1-800-603-6000 and ask to get our toll-free number published in the business section. To reach Colly Brazil the number is 1-800-345-1503 extension 1324.
