Reading/Study/Discussion of the 1<sup>st</sup> Concept using chapter questions.

- #1. All groups present hold regular business meetings although one or two often have very little participation. Q: How do we encourage participation? A: Set a positive example extol the positive aspects of being of service to others. Suggest to sponsees that they may want to get involved in service as another aspect of the total recovery package.
- #2. Most responding groups do not usually, specifically discuss how they can better fulfil our primary purpose. One spoke of putting the group's actions within the context of the primary purpose. Another group does not specifically speak of the primary purpose as such, but bases their actions on how best to provide an atmosphere of recovery that indirectly pertains to our primary purpose.
- #3. In response to the third question, in general, many of the smaller groups rely on the Area to provide those services, such as PI, H&I, literature and activities, that are beyond their means and financial resources. The larger group is more able to attend to these services.
- #4. In large part it seemed that geography is key in determining how much the groups relied on the Area for providing the above mentioned services. Smaller groups, in the same locality, could best pool their limited resources and avail themselves of the combined resources of the Area which initiates and maintains services that any one group would be unable to provide. More isolated groups, tending to be larger, are better able to provide those services and relieve the Area of the additional burden. In general it is not a question of right or wrong, but what works best for a given set of circumstances.
- #5. The first part of the last question is most since those responding are obviously in attendance. As for monetary contributions, all groups contribute what they can, when they can most regularly.

- 3) Discussed finances and decided to hold an Executive session later this month, before the next ASC meeting, to balance and determine budgets and figure out what the ASC had decided to base Regional and NAWS donations on.
- 4) Discussed the upcoming CAR workshop and the importance of attending.
- 5) Discussed the CAR tract materials and how to obtain.
- 6) As the Webservant for the Region, Richard M. asked for permission to use an adapted version of the "Wyo-Braska Web Site Policy and Guidelines" for the Region. After little discussion a consensus was reached allowing the Region to use the ASC guidelines. No motion.
- 7) Earlier mention of a group needing to renegotiate rent being paid to hold meetings in a church facility prompted a bit of discussion about Tradition Seven. While we are fully self-supporting and do not accept outside donations, this does not mean that we have to pay for the use of a facility if that facility opens it's doors to other groups as well. If NA would be singled out for special treatment then there would be a conflict. As long as a service, be it rent, a PSA, a newspaper notice etc., is provided to all non-profit organizations indiscriminately we are self-supporting in that we avail ourselves of the same benefits as all other organizations.
- 8) Discussed the changes being contemplated by the Clean and Serene group to the opening preamble. Essentially the words "Out of respect for the Narcotics Anonymous program . . ." will be added in front of the sentence "We ask that you use **Narcotics Anonymous** language in all that you say at this meeting." The intent is to clarify <a href="https://www.we.use.nd/">www.we.use.nd/</a> language in order to further emphasize the non-affiliation with other twelve step programs in particular AA. Tradition Four grants each group autonomy to conduct meetings as they see fit for their particular circumstances as long as the action does not affect other groups or NA as a whole. This was brought up in sharing simply so that other groups experiencing difficulties with implied affiliation might have a viable means to clarify the difference.
- 9) An excessively large phone bill prompted discussion on how to remedy the situation. It seems that our toll free number was dialed by someone in Nebraska and then apparently left connected for close to an hour. We are billed by the minute so that's why the bill was so high. Kathleen said she would call the phone company and plead our case and see what can be done about it.
- 9b) While on the subject of the phone bill a Clean & Serene group member brought up the lack of a donation by the C & S group to the Area for at least two months and how this may be causing "hard feelings" between the Area and the C & S group. Some time back the group had voted to discontinue their own phone service and donate \$35.00 to the Area instead.

And yet no donation had been given for the last two months. The explanation was that even though voted for, at any time the members at a business meeting can vote out a previous decision. Due to slumping 7<sup>th</sup> Tradition donations and increased expenses the group had voted at the last two GSC meetings not to make the donation. This does not mean that we won't vote to make any future donations. It is a month by month decision.

- 10) Next, discussion revolved around the posting of Handicap status and if this is appropriate and if so when. Some facilities are documented as being Handicap accessible on both the NAWS web site and on our web site and yet they really do not meet the requirements as outlined in the Americans with Disabilities Act. It seems that the distinction is in wether or not a facility is considered to be public or private. NA meetings, while some are "...open to anyone wishing to experience the fellowship." they are not considered to be public facilities. Therefore the handicap requirements are less strict and generally, if a wheel chair can be rolled into the facility unaided then it can be considered handicap accessible even if the person may have some difficulty using the restroom. The key seems to be in providing an atmosphere of recovery for as many as possible and if a meeting is noted as handicap accessible then people searching the meeting lists will know that they can at least attend. Then other members can assist them in getting around inside the meeting which is not true in a public setting where the wheelchair bound are left to fend for themselves.
- 11) The next matter discussed is one that has never come up before and posses a significant problem in providing an atmosphere of recovery in which the entire family may feel comfortable. It seems that at some meetings some people are getting "frisky" either in the bathrooms or in the hallways outside the restrooms or even out in the parking lot. On occasion, members are involved in body piercing during the meeting and those sitting in the rear often carry on conversations not related to NA. And often court ordered members come to the meeting to call in, with the meeting hall caller ID being shown, and then leave without attending the meeting. All in all, an environment that is not conducive to recovery.

Group issues do need to be addressed at the group level, but since these problems may tarnish NA's image as a whole, at least in the afflicted locality, we can offer suggestions and therefore it was appropriate to bring to the Area. Ultimately it may come down to a matter of leadership and having trusted servants confront the transgressors personally and ask them to either leave the inappropriate behavior outside or not attend until they do. It may <u>not</u> be best to openly confront an individual in front of the rest of the group. It is usually best to ask the person off to the side where they can be privately talked to. Honesty not tempered by love may be cruel.

There is a very subtle distinction between not allowing the behavior and not allowing the person within the meetings. Many may take the rebuke personally and interpret it to mean that they are being kicked out even though according to Tradition Three "The only requirement for membership is the desire to stop using." The distinction is that the person is welcome – not the behavior. In some instances the proper authorities may even need to be called.

12) GSRs were encouraged to ask their groups to help fund travel expenses to workshops. Those attending workshops will always come away from it with new knowledge and insights. Sometimes these get togethers may be the only way new ideas can be introduced to the group.

Sometimes we are faced with a very small pool of volunteers, but must not be tempted to elect "a warm body." It may well be better to leave a position vacant rather then possibly damaging NA's image or inhibiting an individual's recovery by electing someone who may be willing but unqualified.
- 4) Rotation of leadership serves several purposes some of which includes infusion of fresh ideas, allowing others the opportunity to serve and dispelling the illusion that one individual IS the only one capable of serving in the position he or she has one individual can be associated with a position too much.
- 5) Essentially NA leadership is an extension of recovery allowing members the opportunity to give back to the fellowship that which they have learned of the principles in recovery. Above all it seems most important to bring recovery into a trusted servant position recovery based service rather then service based recovery. Selflessness is fulfilling a commitment even when one would rather be doing something else.

- 2) Chris was curious about the letter that Ray referred to. Did the letter reference a "rigorous specific number" of people attending jail and other institutional meetings or was it phrased as a recommendation. Further discussion was tabled until the next meeting when we can actually get a copy of the letter to review.
- 3) Cheyenne juvenile detention meetings are having problems with contraband being smuggled inside by people who say they are from NA when in fact they may not be. It was suggested that a double list of qualified members might provide a way of assuring that only NA members attend these meetings. In other words, a master list would be compiled by Kathleen (or the acting H&I Chair) and given to the center. This body, i.e., the H&I Chair or acting Chair would prescreen volunteers for inclusion on this list. Then this list would be compared to the list the center maintains of those individuals who have applied and met their requirements. Only those on both lists would then be allowed inside. Kathleen will check into this possible solution.

#### **Old Business:**

- 1) URMRSC and NAWS donations. After a bit of clarifying, it was thought that we would donate 10% of the net income in the general fund (after all donations and the extra S&H from literature was added up and expenses deducted) to each entity. This way we would not be using a % of funds that a previous donation had already been taken out of.
- 2) Liability insurance: Little input had been gathered, but several questions were posed. Letter to Clean and Serene group and response by recently elected GSR, Richard M.
 Discussion in attempt to clear the air about the Group's participation at the Area and donations to the ASC.

Participation, or lack of, can be attributed to several things. An overall decline in attendance throughout the summer months has been experienced and not just by the C&S Group. A conversation with a local AA GSR revealed that attendance, participation and donations were down in most all of the AA groups around Scottsbluff too. The C&S Group also had several members with enough clean time, but no transportation or they were on probation or were already fulfilling duties at the group level. Others were simply

tired of serving. Still others, many of them Old Timers, were not attending meetings for what ever reason. The bottom line is that the C&S group <u>has</u> been represented at all but one meeting in many months and while they can perform many of the same functions as the Area, they still need the input for difficulties and the connection with the Region.

#### **Sharing Session:**

1) Phone line service: There appears to be a consensus on the need for the phone line and publications. Given the tendency for many to us rely on technology we sometimes forget that there are some who do not have access to computers and who may not know how to use them even if they did have access. However, virtually everyone has access to a phone and phone book. For example, there are those from treatment facilities who call and of course out-of-towners usually only have a phone.

A brief history of area funds, fund raising and the budgetary process was presented. While the phone line and books have been budgeted for in the 2006 – 2007 budget year unless group donations and other fund raisers significantly improve it may be difficult to continue this vital service.

2) Chair summary: In response to the question of having the Chair provide a summary one group was for it, three against it and four offered no opinion. Generally it was felt that the summary contained the same information that a GSR or other representative would report to his or her home group on.
