# Group Response to Concept \_6\_ & Question \_4\_from last meeting:

Group conscience is the spiritual means by which we invite a loving God to influence our decisions. Group conscience is the means by which we bring the spiritual awakening of the Twelve Steps to bear in making service-related decisions. It is fundamental to our fellowship's decision- making process. It is not, however, merely a euphemism for "voting" and is not itself the NA decision-making process.

4.Read NA's Twelfth Tradition. How does the practice of the Sixth Concept help us focus on "principles, not personalities" when we make service decisions?

Spirituality is a principal and people have personalities. The sixth concept actually defines the difference between the two words in the twelfth tradition. Anonymity is a principle that is not operating on self-will.

Web site: As mention by Les (& others) the web site is not up to date. After working on several other chores, attention was turned to the web site. # Group Response to Concept \_10\_ & Question 3\_from last meeting:

Any member of a service body can petition that body for the redress of a personal grievance, without fear of reprisal.

When is it appropriate to apply the Tenth Concept? When is it not appropriate? Simply put, it is appropriate is NA service matters and it is not appropriate for personal issues.

## Reading/Study/Discussion of Concept \_11\_ using chapter questions.

NA funds are to be used to further our primary purpose, and must be managed responsibly.

The Eleventh Concept establishes the sole absolute priority for the use of NA funds: to carry the message. The importance of that priority calls for total fiscal accountability. Direct contributions to each level of service help us focus on our primary purpose and enhance accountability.

## Study and discussion questions

1. What is money used for in your group? Your area? Your region? Your world services?

Most groups use the funds for rent, refreshments and literature. Due to the nature of the C&S meeting hall they also purchase cleaning supplies and some building maintenance items when they are directly donated.

Area funds are used for functions, both celebrations and occasional workshops, literature, printing such as meeting lists and fliers, travel expenses to Regional meetings by our reps, an info phone line and a web site.

Regional funds are believed used predominately for travel expenses to the WSC, Region meetings and Regional forum meetings as well as rent, printing and a web site.

NAWS funds are believed to be used for travel to various workshops around the world and both literature development and sales. Funds are also used to provide literature to correctional facilities and others who cannot buy it. Also, service offices are maintained in California, Canada, Europe and maybe one in the Middle East. And a considerable amount of money is spent on legal issues including protecting and defending our trademarks and copyrights. There are also audits performed to make sure all monies are accounted for.

2. Rank the following group budget priorities:

Of those responding, priorities were about the same. 1) Meeting-hall rent, 2) NA literature, 3) Refreshments, 4) Group reserve & 5) Service donations.

Why did you rank them in the order you did? The rankings seemed logical in order to best see to the primary purpose and providing an atmosphere of recovery.

Does your group have standing budget priorities, or does it handle such questions from month-to-month? Some do, others are month-to-month and others a combination depending on circumstances.

3. Do you know of instances where NA money has been spent frivolously at the group level? In an area or regional committee? In world services? What was "frivolous" about the way that money was spent? How should it have been spent instead?

This question did not generate much response. There was one instance, unknown at what level, where some extra funds were discovered and used as a reward for hard work done. This may or may not have been frivolous and if so then it could have just been added back into the general funds.

4. Are NA funds well-accounted for in your group? Your area and region? In world services? If not, what kinds of financial reports would you like to see instead?

## GSRs -- take this question back to groups for input.

5. "Direct group contributions to our service structure encourage responsible management of service funds and help our services maintain their focus on NA's primary purpose." Does your area or region depend on NA fundraisers for a significant portion of its income? Is that wise? How does it affect the relationship of the ASC or RSC to your group? Would that relationship be any different if groups contributed directly to each level of service? Would our service boards and committees be able to operate solely on income from direct group contributions?

In our area, group contributions may not always be enough and fundraisers alone have not proven to be enough to provide the services groups want and need. For us, the budget depends on a combination of both and responsible resource management.

T-Shirts & bandannas – Shirts have been delayed, but based on new information we ought to be able to order, offer and sell only those shirts most popular with a smaller amount of left over inventory. A Unity Days committee member who is also the activities chair for the Clean & Serene group wanted me to present the info on the Unity Days shirts to that group.

From the ensuing, enthusiastic discussion, the group decided to use a dry erase board to record who wanted what sizes. Some wanted 4XL shirts that were unavailable from Scottsbluff Screenprinting (SS). At first it was thought that they would have to bring in their own shirts and have them printed up. SS said they would do this on a limited basis for ½ the regular charge. But then exact same brand shirts were found on eBay for about half the cost (\$6.25 ea.) as offered by another supplier in Scottsbluff. There was, however, a 1 dozen minimum order.

The group had 25 pre-orders out of the 36 available and quite a different size distribution than I had initially calculated. Based on the numbers, previous experience & the recommendation from another convention savvy committee member, the most sought after sizes seem to be the XL, 2, 3 & 4Xs and the least wanted were the smalls.

The Clean & Serene group decided on sport gray and we decided on a relative compromise of navy blue. Rather than order a dozen for each entity I ordered a dozen from the seller on eBay - 6 of each color. Based on all of this additional information I am better able to come up with and exact price for the first order and we can still get them in soon, do up some fliers with photos of them and get to selling them and still have time for a second order if sales justify the need. After some discussion, we will try to get a small order of hoodies printed up with our second order.

Also, solid center or solid color bandannas were a harder to come up with, but I was finally able to get a few dozen with a variety of colors – dark green, fire engine green, hot pink, dark yellow, dark blue, black and purple. Will come up with a flier for selling.

Richard reported that the Scotts Bluff County Corrections had asked him to help with a new program they have started called "Introduction to Twelve Step Fellowships." The program is non-fellowship specific using materials from AA, NA and what ever other program inmates may want and where materials are available. Last Saturday Richard spoke to a coed group of about 50 – 10 women and 40 men. He was able to share his story without there being an affiliation with any specific program. Afterwards he learned that a large percentage of the population were Spanish with Spanish as there first language. While he spoke some were interpreting for others and it

would be nice if they had Spanish literature to refer to. It just so happens that NA does have the first part of the Basic Text in Spanish. He would like to see if the PR sub-committee has the funds and willingness to donate at least two Spanish texts to the facility. More in sharing.

Rory agreed and requested two books be ordered.
- 2) Web site Additional changes were discussed including implementing the blind e-mail forwarding to trusted servants and setting up some blind links to GSRs on the Meetings page. Both good ideas and doable.

# Group Response to Concept \_11\_ & Question \_4\_from last meeting:

NA funds are to be used to further our primary purpose, and must be managed responsibly.

Are NA funds well-accounted for in your group? Your area and region? In world services? If not, what kinds of financial reports would you like to see instead?

Clean & Serene reported that their funds are currently well accounted for and believe that for the well being of the group any excess needs to be passed along the service committee chain. Area funds seem to be well accounted for as reported in the area minutes. No one seems to know much about the Region and those minutes don't say much. And even though NAWS produces annual financial reports based on audits, at least one member would like to see some of the items and or categories broken down more than they already are, i.e. postage. Postage is pretty general and the member wonders how much of this is for free literature, office mailings, regular order short falls, etc.

# Reading/Study/Discussion of Concept \_12\_ using chapter questions.

In keeping with the spiritual nature of Narcotics Anonymous, our structure should always be one of service, never of government.

Within the context of the Twelve Concepts, as a body, this concept serves much the same function as Tradition Twelve does in the context of the other traditions. The Twelfth Concept brings our consideration of concepts for NA service back to the spiritual root of selfless service. A structure based on that foundation could only be one of service, never of government.

# Study and discussion questions

1. What is the difference between service and government?

Service does not rule or govern. It is serving others selflessly and with humility. Service is giving it away. Government is ruling or governing. It is often selfishly motivated and a matter of pride and taking what it can.

2. The difference between a governing organization and a service organization is often not of structure but of spiritual foundation and purpose. What is it about NA's primary purpose and its spiritual identity that says "our structure should always be one of service, never of government"?

Selflessly giving it away – carrying the message to the addict who still suffers and by each level of service asking "What can we do to help you provide an atmosphere of recovery so you can best carry the message.

3. The essay on the Twelfth Concept talks about how gratitude, humility, communication, and selflessness help our structure remain "one of service, never of government." Discuss these things.

These traits are rarely found in government and by definition applies more to serving others.

4. Discuss how the Twelfth Concept applies to each of the eleven other concepts. <u>GSRs -- take this question back to groups for input.</u> Roll Call: Chair, Vice Chair, Secretary, RCM, PR Chair, Literature Chair, Activities Chair, UD Chair, Webservant

I have done up a flier touting the shirts and bandannas and have myself listed as the Scottsbluff contact and Lucretia as the Cheyenne contact since she kind of took over merchandising from Crystal. However, after some discussion, Willy volunteered to take about half of the remaining items with him to sell during his travels.

**Merchandise seller** –It has been confirmed – the Off the Wall Area in Colorado will come to Unity Days and offer jewelry and other NA items. We will most likely comp at least one seller the weekend.

**Registration/Flier:** We have another flier touting speakers, events and activities with only the area's web site address for direction to a registration flier. These fliers can be emailed or posted around various groups' meeting places drawing attention to the upcoming event and all of the neat, fun things available. We will pass these out at the area meeting to all of the GSRs and email them around.

**Registration Package:** We have a sold four full registrations with \$100 to be turned in to the acting treasurer. Fifteen registration packets have been made up so far. Three were given to Mistie W. for the speakers, one was given to Robert N. for having submitted the winning logo, two were given to registrants and nine were given to Mistie to pass on to Gail W. our registration chair. An additional 10 laminated name tags and book marks and 20 cards were also included in the stuff going to Gail in the instance where two or more people were registering together.

As previously discussed, we will just make up the name tags, punch them and tie on a hunk of yarn and then mark names on them as needed. I tried this with a permanent marker and after letting it dry, it was hard to wipe off except with an erasure. This process will free up time for other chores.

At this point the contents of the registration packs has changed a little. A separate flier is included in them listing the weekend schedule and activities as well as a little blurb listing times and prices for zoo visits and then a full color map of the zoo. Of course the laminated bookmarks with the logos on the front and the promise on the back is included, but instead of laminating the business cards they are just put in as they are. The cards are just too thick for the laminator. Then there is a laminated name tag prepunched and tied with a piece of yarn. As people register we will use a permanent marker to write their names on them. And of course the logo magnets are included. I'll try to come up with detailed maps of the Trails West YMCA, the Riverside zoo, campground and park and make them available at the registration table.

Scottsbluff members Suzanne and Kathy have volunteered to help at the registration table and shirt sales respectively.

**Speakers:** Mistie has all three speakers lined up including one each from Washington, Casper and Cheyenne. All three will be given comp registration packets as per previous discussions and our custom. Also, we have a Basic Text donated for the clean time countdown and we may also get a 'lt Works: How and Why" and maybe a "Just for Today"

**Meals:** Between now and the next meeting all of the menus and Robert and Lucretia's shopping figures will be compiled into one master list. Many items, duplicated between meals, can be combined into one purchase thus saving money. Robert N. is still going to be able to transport everything from Sam's Club to Scottsbluff with the perishables in coolers.

Carl L., had volunteered his services and Larry B. from Scottsbluff (another professional chef) has also volunteered his help with the cooking.

Willy assured us that all of the drinks have been taken care of using coolers he and Richard are loaning us. We will only need to figure in the cost of ice.

**Banner:** Robert is just about done with the drawing and Richard will mail him a tie dye kit he got on a super sale at WalMart. The kit had been marked down from \$20 to \$3. No word on any of the other banners. There aren't any in the totes.

Raffle Items: Hey everyone – how about going through your NA paraphernalia and digging up some stuff to donate for a good ole fashioned raffle? Just about anything is okay with NA stuff preferable and non-NA okay as long as it does not refer to any other fellowship. You know – like a nice display rack for NA mugs or somethin' like that? And of course we will have a 50/50 raffle.

# **Other:** Rory G is going to get with Craig H. about getting the NA signs. And Robert said he thought there were a couple with the totes.

Addendum: July 23, 2008

I met with Willy O. yesterday in Kimball, NE and gave him the rest of the shirts and bandannas. He had earlier called to let me know that he had sold almost all of what he took with him at the 13<sup>th</sup> meeting and that was almost half of the entire order less what was sold at the area meeting. So it looks like we will indeed be needing another order before UDs. With the \$125 turned in on the 13<sup>th</sup>, total sales are now at \$395. Our total cost was \$482.62 so we are doing well. If we sell everything we will clear \$187.38 so we have a little elbow room.

We do now have at least 7 hoodies spoken for and another possible 3 so I may be ordering as many as 10 hoodies as well as another 2 dozen bandannas and at least another 2 dozen t-shirts. Hopefully this will be enough without being to much. A few leftovers is fine, we just don't want a lot of them.

**PR:** Rory reports that he has been checking with correctional facilities in our area to determine NAs current status within their institutions. Albany and Laramie county corrections currently each have one qualified NA member each who has been approved for holding NA meetings within the jails. The main draw back is that these institutions require that the volunteer have absolutely no felony convictions what so ever. As most of us are aware, this is problematic because of the nature of the disease and the high incidence of drug related felonies. The few without convictions may not have the time or ability to attend jail meetings so it's going to be difficult to find qualified and willing volunteers.

Rory was unable to get in touch with the contact for the Scotts Bluff County Corrections, but was given the names and phone numbers of the two Scottsbluff chairs. Of note, Scotts Bluff County does not have the same restriction but it does require that volunteers not have any family members currently incarcerated and it's preferred that volunteers not have been incarcerated themselves in the past year. Also of note – Rory presented the Scottsbluff Clean & Serene group's GSR with the two Spanish versions of the Basic Text promised at the last meeting for the corrections. Thank you very much. The texts will be given to the jail.

**Phoneline:** Reported on in Vice-chair report, but Rory said that he had been in touch with Tommy O. and the info line was operational and up-to-date.

**Web site:** Richard M. reports that the web site is mostly up to date and working well. As time allows Unity Days minutes, additional fliers and whatever else will be added. The ASC page will be incorporated with the Archives page and then the Regional convention page redesigned. Meetings are up to date and the newest meeting list posted.

# Group Response to Concept \_12\_ & Question \_4\_from last meeting:

In keeping with the spiritual nature of Narcotics Anonymous, our structure should always be one of service, never of government.

Within the context of the Twelve Concepts, as a body, this concept serves much the same function as Tradition Twelve does in the context of the other traditions. The Twelfth Concept brings our consideration of concepts for NA service back to the spiritual root of selfless service. A structure based on that foundation could only be one of service, never of government.

4. Discuss how the Twelfth Concept applies to each of the eleven other concepts.

Every other concept goes back to the principle of service and not government where everyone has an equal say in discussions and making decisions.

# Reading/Study/Discussion of Concept \_1\_ using chapter questions.

To fulfill our fellowship's primary purpose, the NA groups have joined together to create a structure which develops, coordinates, and maintains services on behalf of NA as a whole.

The primary responsibility of an NA group is to conduct its recovery meetings, carrying the message directly to the addict who still suffers. Groups join their strength in the service structure, ensuring that other services—H&I, PI, literature development, for example—are fulfilled effectively and without distracting the groups from their own primary responsibility.

# Study and discussion questions

- Does your group hold regular business meetings? (See *The Group Booklet*, pp. 9-10.) For the most part – yes – everyone holds regular business meetings, but the question is how to get members to attend and get involved in the business meetings?
- 2. Does your group regularly talk about how it can better fulfill its primary purpose? Not necessarily specifically at every meeting – it is, however at the back of members' minds while they tend to business matters. Some meetings state the primary purpose as the main reason for gathering as an opening.
- After paying the expenses for literature, refreshments, and meeting-hall rent, does your group have enough money to conduct other services on its own? Hopefully at least some in case it is needed, but not always. Sometimes 7<sup>th</sup> tradition donations barely cover expenses.
- 4. Can your group perform a variety of organized services like PI work, H&I panels, phoneline management, and literature development while still attending to its recovery meetings? GSRs -- take this question back to groups for input.
- 5. Does your group send a representative to your local area service committee? Do you contribute money to your ASC on a regular basis? Usually GSRs attend area meetings and groups contribute whenever they are able.

Then the regional convention page was re-established. Meetings are up to date and the newest meeting list posted.

It seems that since redesigning the site the hit counter was reset so that when it was checked less than 24 hours ago it registered 1243 hit. This is apparently the accumulation since the site was redesigned in the middle of last month and with less than 24 hours an additional 62 hits were recorded. Someone's using the site. Hopefully it is people interested in the Unity Days.

The domain name registration and a year of hosting fees will be automatically deducted from the checking account next month. The domain name will be renewed on Sept. 3<sup>rd</sup> and is \$9.99 and then the year of hosting, with 10% discount, will be deducted around Sept. 20 for about \$97.00. All fees have been paid up until then.

Literature: Mistie W. reported that since the last ASC meeting the Cheyenne Anchors Away group had contacted her and placed a substantial order for literature. They paid for most of it with cash and a check made out to the Area for \$11.00. A money order was purchased and made out to NAWS and this order was included with the regular order. Mistie needs \$11.00 cash for the check and then is turning in \$7.32 for the general account which reflects 3% of the additional order. She also reports \$40.36 in sales. She is asking for \$68.05 for this month's order which replaces what was sold and includes a supply of the new youth pamphlets. Lookin' good! Thank you Mistie.

## Sharing Session:

 Fiscal Year – The fiscal year ends August 31<sup>st</sup> so all of the executive committee and the committee chairs need to prepare a budget for the coming year and present it at the next ASC meeting.

2) URMRSC grievances – At the last regional meeting there were three grievances filed with the service body including inappropriate removal of the webservant in 2006, slanderish language used in a report presented in the regional minutes and of more concern for our area – questionable use of the new logo. There is also the matter of some rewording in the regional guidelines.

The guideline change that pertains to the Wyo-Braska area is section 1, par. B where the wording was changed from

"This committee shall serve geographical areas of Wyoming and Nebraska as deemed appropriate. We shall have the option of including neighboring areas when necessary."

to

"This committee shall serve geographical areas of the US state of Wyoming. We shall have the option of including neighboring areas when necessary."

Somehow the omission of Nebraska from the line was never questioned. The reason given for Nebraska being left out was to avoid confusion between the Upper Rocky Mountain Region, which is primarily Wyoming, and the Nebraska region. And yet throughout the guidelines and the regional web site the Wyo-Braska Area is still used profusely. A simpler and perhaps more acceptable change could be "... and the Nebraska Panhandle..." This would provide a clear delineation between the Nebraska region and the URMR. Our RCM was asked to propose this change.

As for the matter of the logo, even though it is now under review by the regional grievance ad-hoc committee, a WBASC member asked that groups in the WBASC give direction on this matter to the RCM to pass along to the regional service committee. We were reminded that this area has already addressed this issue and has never been in favor of using the State of Wyoming bucking bronco. It was strongly encouraged for us to stay the course and consensus affirmed continue opposing its use.

3) PI announcements at college papers: The University of Wyoming school paper – the "Branding Iron," charges \$2.70 per week for one ad or \$2.50 per day when run two or more times a week. It comes out on Tuesday and Friday. Rory was wondering if this is a viable outlay of resources in making meeting times and locations available to post secondary students who may well benefit from NA more than other targeted populations. Most thought this a good idea and that maybe he could also check with Arlene for LCCC and maybe someone from the Western Nebraska Community College in Scottsbluff and the tech college in

Torrington. The PR budget is the H&I and PI combined and it is thought to amount to around \$900.00 total per year. Out of this comes the web site domain name registration and hosting fees, the info line and placement of the toll free number in several phone books and any literature needs in the form of *Basic Texts* and pamphlets to correctional facilities, mental health organizations and any other public agency that may need info.

It's up to Rory as the PR Chair to consider what we already pay for, what was left over from this last year's budget and how much we may need in the coming year and what additional services we can manage. All of this can be figured in for this years budget request. Good job.

4) URMRSC guideline change, i.e. change meeting months: It was proposed to change the meeting rotation schedule and add in the new area so they can have their turn under section 4, paragraph A. Change May to April and making this the annual regional assembly/workshop, add June and change November to October. Other areas of change would include adding the new area to the convention rotation under section 11, paragraph A and changing the months of trusted servant elections to match the new meeting schedule in section 8, paragraph A.

# Group Response to Concept \_1\_ & Question \_4\_from last meeting:

To fulfill our fellowship's primary purpose, the NA groups have joined together to create a structure which develops, coordinates, and maintains services on behalf of NA as a whole.

The primary responsibility of an NA group is to conduct its recovery meetings, carrying the message directly to the addict who still suffers. Groups join their strength in the service structure, ensuring that other services—H&I, PI, literature development, for example—are fulfilled effectively and without distracting the groups from their own primary responsibility.

4. Can your group perform a variety of organized services like PI work, H&I panels, phoneline management, and literature development while still attending to its recovery meetings?

C & S – We can and do PI and H&I activities when we have experienced members step up to do it. At times all we can do is pass out meeting lists and attend jail meeting. Sometimes we just can't because we do not have the resources and time for a web site, phoneline and especially literature development.

Most of the Cheyenne groups are small enough that they just do not have the resources to do anything except fulfil the primary purpose placing meetings as the number one, and sometimes the only, priority.

# Reading/Study/Discussion of Concept \_2\_ using chapter questions.

The final responsibility and authority for NA services rests with the NA groups.

The groups have final responsibility for and authority over the service structure they have created. By fulfilling their responsibility to provide their service structure with the conscience, ideas, people, and money it needs, the groups also exercise their authority. Conversely, the service structure must always look to the groups for support and direction.

# Study and discussion questions

1. In general, what does your group think about the concept of delegated authority? <u>GSRs -- take this question back to groups for input.</u>

2. If your group were consulted on every decision that had to be made by every service board, committee, or subcommittee at the area, regional, and world level, would you still have enough time and energy to address your own group's business? Would your group have enough information to be able to offer intelligent advice on such matters? No we wouldn't – we would be inundated with information overload and not able to be of much help.

3. If the service boards and committees serving your group could act only after consulting your group, would they be able to act swiftly enough in performing the duties your group has given them?

Even with monthly meetings probably not. Most groups are in touch (thru GSRs etc.) so direct input not needed on every item. If the Region had to ask groups about every question, since the Region only meets quarterly, actions would be way too slow. However, some issues important enough to seek direct group input.

4. In the essay on the Second Tradition in our Basic Text (p. 60), it says "We are mismanagers and not one of us is capable of consistently making good decisions." If this is true, how can we responsibly delegate to our trusted servants the kind of authority called for in the Third Concept?

No one person makes a decision and if so then is held accountable. Decisions are based on serving and on the way others direct – in a general way.

This is not a blank check issued to the service structure; the group's final responsibility and authority, spoken of in the Second Concept, still apply. To make Concept Three work, we must carefully select trusted servants.

# **Discussion Question**

1. In general, what does your group think about the concept of delegated authority?

C & S – The groups have the final say and it is heard provided the GSR does the appointed job.

# Reading/Study/Discussion of Concept \_4\_ using chapter questions.

# Effective leadership is highly valued in Narcotics Anonymous. Leadership qualities should be carefully considered when selecting trusted servants.

The trust necessary to confidently delegate authority is founded on the careful selection of trusted servants. Leadership is very important to the welfare of our fellowship. True, our leaders are but trusted servants, not governors; yet we also expect our trusted servants to lead us. If we select them carefully, we can confidently allow them to do so. The essay on this concept describes an array of leadership qualities to be considered when selecting trusted servants.

# Study and discussion questions

1. Read NA's Second Tradition. Does NA have leaders? If so, what kind of leaders? Does a fellowship that makes collective decisions need leaders?

Yes, NA has leaders who are trusted servants. Govern is to dictate. Leaders don't dictate but guide and serve. the best leaders are good followers.

- 2. Does your group have leaders? If so, who are they? In what sense can they be called "leaders"? Could your group do without leaders? Could a service board or committee do without leaders? GSRs -- take this question back to groups for input.
- 3. According to this essay, what are some of the skills and personal traits we seek when selecting trusted servants? What is the real foundation of NA leadership? Must have service experience and be able to follow direction. Must have an attitude of humility. A modest spirit, not driven by ego but which allows others the opportunity to develop their skills and then step aside and watch the continued growth. Must bring spiritual based recovery into the service structure rather than have service based recovery which expresses self-will more than spirituality.
- 4. "Effective NA leadership knows not only how to serve, but when it will serve best to step aside and allow others to take over." Discuss rotation of leadership.



If we step aside, as per the guidelines, and invite others someone will eventually step up. Otherwise the same person holding the same position could be view as having a governing personality and therefor contrary to the guidelines, traditions and concepts.

5. What does NA leadership have to do with recovery? With selfless service?

In recovery we learn selflessness. Selfless service is one more tool for growth. There is no higher purpose, no better way to give back to the fellowship than to selflessly serve. We can only stay clean by giving it away.

Hello Family,

It is good to see you all again. Last weekend I was unable to attend the region meeting as I was in New Orleans. Our RCM2 did fill in for me and I must thank him for doing an exceptional job. There was a motion made to change the area [region??] guidelines back to include Nebraska. This vote failed with 5 for, 5 against, and 2 abstaining. It was mentioned that we add "Pan Handle [Panhandle] of Nebraska" next to "United State of Wyoming" and a vote is needed from this body on this issue.

The new rotation for URMRSC meetings have been scheduled as such: February (Central Wyoming), April (Central Basin), June (Western Wyoming), August (Wyo-Braska) and October (Freedom Seekers Area).

From a committee report from Delynda S. "Several members from this service body met after the last Regional Business meeting to address personal grievances brought by a member of our fellowship. We did not hear back from him and he had made a decision that if we could not reach him y the next scheduled meeting then we would put the second place runner up logo into effect. the member seemed to understand our position on wanting to finally move this item off of the agenda. 3) Slanderous language in a report printed and published in regional minutes: The committee and member bringing the grievance both agreed this was more of a personal issue between two members and was best handled between them. No action was taken by the service body."

A new group in Lyman is meeting ("Clean and Serene") on Tuesday and Thursday at 8:00 pm. Jackson has a new group that meets at 5:30 on Wednesdays. The "Free at Last" group has closed the Thursday night meeting in Thane.

Wyoming Western Area learning day will be held in July and Rawlins and Saratoga are talking about hosting a function. More will be revealed. The next area WWA meeting will be held Dec. 6 in Evanston, WY in conjunction with the "Living Proof" group's 20<sup>th</sup> year annual birthday celebration. There will be Mexican food and a speaker and a raffle. We are also taking orders for shirts. This function will be held at the Beeman Cashin Building in Evanston at 10<sup>th</sup> and Front St.

Three new service pamphlets will be released this year as "Leadership," "The Benefits of Service" and "An Introduction to NA Meetings." Service IP "An Introduction to NA Meetings" was pulled from our shelves after distribution. With a few minor edits World Services is reporting that this piece will be ready for re-distribution in the near future. Also, revisions to the service IP "Service and the NA Member" are to possibly include a section on leadership. #### Sharing Session:

1) What do the groups need from the Area Service Committee? How can we [the ASC] help create unity?

2) Les elaborates on the time lapse in motions made at the region and sent back to areas or groups via the area for consideration. In essence, the different service bodies ought to be allowed to decide matters through the trusted servants we elect without the matter having to go back to another body. For instance, once groups or areas donate funds to the region the region should be able and trusted to use those funds appropriately without having to ask groups and areas first. Several principles from the *Twelve Concepts for NA Service* relate to this delegating of authority – in particularly number three. However, it was pointed out that concept two states that "The final responsibility and authority for NA services rests with the NA groups."

3) What about RCMs only voting on money matters at the regional level? One member felt that the executive

committee should be the only ones who vote on money matters since areas, thru the RCMs, have voted on and donated these funds to the region. They have effectively relinquished control over them. Maybe they should just let go of the funds and allow the region to do it's job.

- 4) Regional grievance ad-hoc committee: Les F. questioned the process for forming this committee believing that it would have been better had the chair appointed all RCMs to sit on the committee. Further it wasn't clear if the grievances were handled or resolved adequately.
- 5) Treasurer and deposits. A member informed us that a check written to the area in June was not deposited and hence not submitted for remittance until October well after the account the check was originally drawn on had been closed. Our guidelines explicitly state that all funds, including checks, are to be deposited within five days. In most cases, checks are no longer redeemable after 90 days. The member has paid the fees but cautions and urges us to be more diligent with our deposits to avoid any future problems.
