### **Technical**

If you have been to our website since the last ASC meeting you will have noticed a few changes. First off, I changed the navigation from the vertical left hand layout to a horizontal drop down menu. In the place of the old navigation I created a space for bulletins such as meeting changes, etc. I have also changed the hope page layout to two columns as to limit the length of the page. I have also added information about Lake Minatare State Recreation Area and contact information for making separate reservations.

I have also worked extensively on the literature order site. It is available at <a href="www.wyo-braskana.org/literature">www.wyo-braskana.org/literature</a>. I still have many products to add to the site before it is finished, however, the trusted servant responsible for ordering literature for each group can go there and create an account and get familiar with the features. Items that are there now can be added to the cart for later processing. Whatever is placed in the cart will remain there until it is removed or the order is processed.

One thing to be aware of is that on some products there are different prices if you order 100 or more copies of an item. There will be a drop down box on the product pages where this is an option. If you choose the 100 or more option, you still have to enter the exact number of copies in the shopping cart at the time of checkout otherwise you will be charge the 99 or less price.

After the checkout process is complete an invoice will be generated and sent to the email address supplied when the account was created. An invoice will also be sent to the literature chair detailing exactly what was ordered. If there are any questions, comments or problems feel free to contact me by email or phone.

I am aware of a couple glitches in the site. They are minor and do not affect overall functionality of the process. The most notable is that sometimes when a product is added to the cart, a message displays stating, "Product not found." I am not sure why this is being displayed but the product does get added to the cart. The shopping cart is always displayed on the right hand side of the page for easy reference of what has been added.

It is my hope that this process will benefit the groups in that they will know what the exact charge of what they are ordering is before the order is confirmed, and secondly they will be able to see everything that is available from NAWS, Inc. This should also benefit the literature chair in that they will know exactly what they need to bring to area and will no longer need to bring their entire inventory with them.

There were 3 emails received in the month of August. One was spam, one was from LCCC about the SNL room rent and one was a response from the Nebraska Region confirming they had been contacted by the Scottsbluff meeting.

## **Visitor Statistics and Trending**

In the month of August our site was visited a total of 133 times. 69 visits were from mobile devices. This included 124 visits from 24 states in the U.S, and 9 visits from 7 other countries. 76 of the U.S. visits originated in Wyoming and Colorado, each having 38. There were 86 new visitors and 47 returning visitors. There were a total of 279 page views and the three most viewed were the Home page, Meeting List and Recovery Literature.

#### **Technical**

I have started working on the online registration section to the Area site. If need be it will be available for taking registrations for the URMRCNA as well as all of our Area functions. However, there is a requirement for us to have what is called an SSL certificate, (Secure Socket Layer). An SSL certificate is what is used to encrypt data transmitted over the internet such as credit card numbers and other personal information. Without one anyone who would use the site to register for an event could be at risk of having their credit card number stolen. I was thinking that we would be able to use a "free shared certificate" but unfortunately over the years they have been abused and at this time they cost \$69.99 a year. I have also created a new letterhead that matches the branding of the website that I am submitting for approval.

## **Financial**

The hosting cost was \$71.88 for the year. We were offered a \$13.12 discount for early renewal which reduced the total cost to \$58.76. The hosting is set to auto renew on August 20, 2013.

The domain name cost for the year was \$9.83 and we were given a discount of \$1.76 for early renewal bringing the cost down to \$8.07. The domain name registration is set to auto renew on September 3, 2013.

In absence of both the Chair and Vice Chair, they shall act as Regional Chair. Attends the RMZF meeting yearly in July and attends the CAR workshop each conference cycle every other December. ## Section 6. Alternate Delegate (AD)

Suggested four (4) years clean time, serves for two (2) conference cycles, preferably two (2) years experience at the area or regional level, assumes the responsibilities of the RD if the RD is not available, attends the WSC, attends the RMZF meeting yearly in July and attends the CAR workshop each conference cycle every other December, acts as the co-facilitator for the yearly Regional Assembly and all Regional Workshops and is a co-signer on the URMRSC bank account.

#### Article XI Money Matters

#### Section 4

The URMRSC will pay all officers thirty (.30) cents per mile to travel to all RSC meetings.

#### Section 7

The URMRSC will fund its AD to attend the RMZF meeting yearly, the RMZF CAR workshop biyearly, the annual regional Assembly and the meeting of the WSC each conference cycle.

#### **Article XII Convention Rotation**

#### Section 1

The rotation for the Regional Convention, URMRCNA, is as follows: Wyo-Braska Area, Freedom Seekers Area, Wyoming Western Area, Central Wyoming Area, and Central Basin Area.

#### Section 2

In the event an area is not prepared to host the Convention, the next area in the rotation would do so. This would be decided in February with the election of the incoming Convention Chair.
