### Service System Discussions that Still Need to Take Place

These are all topics the board plans to devote time to during the 2012–2014 conference cycle. We welcome your thoughts or any input from your community.

#### **Large (NA population) SNPs**

The idea of a single body to conduct state/nation/province PR activities and coordinate efforts among the LSUs seems potentially unrealistic for places such as California or Brazil where the size of the NA community is so large. We need to elaborate on these sorts of possible exceptions to the SNP model and offer an alternative for these states/nations.

#### **Small SNPs (NA population)**

On a related note, some small states or countries do not currently have their own region (e.g., the countries within the Adriatic Region or the states within the New England region), and it's not necessarily the intention of the Service System Proposals to break up these regions. We need to offer an option or options for states/nations/provinces with smaller NA populations.

#### **Seating Criteria (WSC)**

While the conference resolved that the primary seating criterion will be state/nation/province boundaries, there are still many questions related to seating that have yet to be answered. What are the other seating criteria? How should very large countries be treated? Very large states? Very small countries and states? What about places like Malta that, because of their geography, will never grow very large? What kind of consideration should be given to a country's position relative to other communities? (This was a consideration that weighed in favor of seating Lithuania, for example.) What other factors, if any, should be considered when making decisions about seating—age of a community, amount of literature translated, services being delivered, etc.?

#### **Role of Zones**

What role do zones play in the new system? The proposal draft included in the 2012 *CAR* has an appendix on this issue, but the ideas in the appendix are more of a brainstorm than a description of how zones might function as a formal part of a system. We need to develop a more concrete recommendation or set of recommendations for the role of zones. We are encouraging zones to give their thoughts on the issue.

#### **RSOs & Service Offices**

How do RSOs and other service offices fit in the new system? To this point we have included nothing in the proposals about service offices.

#### **Lit Distribution**

If the local service body meets quarterly rather than monthly and the group forum is ideally a place where no business happens, how do groups receive their literature? The proposal draft included in the 2012 *CAR* has an appendix on this issue, but the contents of the appendix are more of a brainstorm than a formal part of a system plan. We need to develop a more concrete recommendation or set of recommendations for lit distribution and fund flow.

**Fund Flow**

On a related note, most groups make monthly donations to an area service body after purchasing literature. If those groups are now affiliated with a local service body that only meets quarterly, how are their donations to be handled? What is the flow of funds between group/GSU/LSU/statewide body...

**Border Communities**

Some ASCs span two states at present and some belong to a region in a neighboring state because that makes more sense geographically. We don't want to necessitate more travel or urge affiliation with a service body that doesn't make logical sense to a given community, but at the same time, border communities need to be able to be informed about and participate in statewide activities (such as H&I to state facilities). We need to offer ideas about how to practically accomplish this.

**Ethnic/Language/Culture Considerations**

Currently, there are many service bodies that have formed because members felt their ethnic or language or cultural needs were not being well met by their existing area or region. If we are proposing a single service body to cover the needs of a city or a county, for instance, we need to consider these ethnic, linguistic, or cultural needs and be able to include strategies to help meet those needs.

**Incorporated Bodies/ Conventions**

We need to provide some guidance on how regions and conventions and other incorporated bodies can handle the transition as easily as possible. There has been a fair amount of concern over the fate of specific regional and area conventions if the hosting region or area no longer exists. Communities need some sort of guidance on how they can retain their legacy conventions and events.

### **Regional Committee Member Report**

**July 14, 2013**

WBASC members and guests,

First off, please excuse my absence at this month's ASC meeting. The NAWS Annual Report is out. The business year of NA World Services runs from July 1<sup>st</sup> through June 30<sup>th</sup> annually with the services of NA running from conference to conference, a two-year cycle. Highlighted in this year's annual report are as follows: A note from the World Board, a listing of our World Services trusted servants including our first full 18 member board, the four member Human Resource Panel and the two Co-Facilitators. The Conference Projects are highlighted, including the Service System Project, The Traditions Book Project and the An Introduction to NA Meetings Project; also the Issue Discussion Topics including Collaboration, Group Conscious and Supporting Our Vision.

Fellowship Development is reported on, including NAWS Workshops around the world and a report on meeting growth. Of the over 61,800 weekly meetings world-wide 27,650 are in the US, 18,664 are in the Middle East, 4,677 are in South America, 3,312 are in Central America, 2,837 are in Western Europe, 1,809 are in the Asia Pacific, 1,369 are in Canada, 1,233 are in Eastern Europe and there are 249 weekly meetings in Africa.

The Report on Public Relations includes a very nice Public Relations Statement, also reporting on the NAWS Membership Survey Pamphlet and the Member Survey. The NAWS Annual Report also reports on our Essential Ongoing Services, including Fellowship Services which the Team averages over 1500 communications per month, Group and Committee Updates, Fellowship Publications including The NA Way Magazine, Reaching Out and NAWS News also their reports, which include the CAR (Conference Agenda Report) and the CAT (Conference Approval Track). These are all listed under Fellowship Services. Also reported under the header of Essential Ongoing Services are Translations. A translations overview is as follows: Languages spoken in NA: 76, IP #1 published languages: 42, Translated literature items published over past 25 years: 951, Basic Text translations published over past 25 years: 22. Current Activity – Active language groups: 23 (LTCs with active projects). Existing projects: 409. Active projects:

349. Book-length projects: 33 which break down as 33 Basic Text, 3 Sponsorship, 3 It Works, 4 NA Step Working Guides, 4 Just For Today and 6 Living Clean. Translated Books published in 2011-2012 were Basic Text Fifth Edition – Polish and Bulgarian, Basic Text Sixth Edition in Swedish, It Works How and Why in Japanese, Just For Today in Italian and the NA Step Working Guides in Hebrew and Japanese.

Also in the translations section of the NAWS Annual Report were reports on Kuwait, Swahili-speaking Eastern Africa, celebrations in India, The Asia Pacific Forum and a Translations Workshop that was held in Iceland.

There is a report from IT which includes statistics. The website was completely revamped in the spring of 2012 and a mobile version was launched at the end of summer. There are now over 75,000 files on the various webservers holding our website. The numbers below include figures from all sources during the year.

#### **Hits/Visits/Views:**

- We finished with over 113 million hits, averaging around 10 million/month.
- We had over 8.8 million visits, with over 22 million page views. Page views have decreased as the site becomes easier to navigate, requiring fewer clicks to reach a desired estimation.
  - Visits continue to rise steadily, currently between 600,000 and 700,000 per month. This is up around 20–30% from two years ago.

#### **Major areas of traffic:**

- The meeting search continues to be far and away the busiest area (with the exception of the *JFT* page—see below), with well over 1 million visits.
- The “Find a Meeting” page has had around 600,000 visits, while the local phonenumber and website page had around 300,000.
  - The new website search we introduced in the spring has been used over 100,000 times since its implementation.

#### **Eblasts and emails:**

- We passed the 64,000 *JFT* emails-per-night mark in December 2012, and we sent out in excess of 20 million emails for the *JFT* alone during the 2012 calendar year.
- The daily *JFT* page on the website received over 1.5 million visits and 2.2 million views.
- Distribution of our NAWS eblasts is continuing to grow. The most recent one was sent to over 96,000 email addresses with less than 1% failure rate, meaning over 95,000 successful deliveries.

#### **Recovery and service material:**

- The recovery literature index page was accessed over 250,000 times over the year, with over 80% of that going on to the English literature page.
- Service material is harder to track because of the new site, but the Service System page has been accessed approximately 9,000 times during this year.

#### **Publications:**

- The top publication online continues to be *The NA Way Magazine*, with an esub circulation in English of approximately 16,000, and continuing to grow.
- Similarly, interest in *NAWS News* is growing, and the most recent issue was sent out to around 13,000, up from 11,000 the previous issue.
- *Reaching Out* is growing exponentially as well, up to around 8,000 esubs.

Also under IT was a brief paragraph on Technology Infrastructure. Lastly, Essential Ongoing Services reported on Production and Distribution, which included sections on Books, Booklets, Information Pamphlets, Chips and Keytags and Medallions.

There are sections in the NAWS Annual Report on Our fellowship's Literature and Trademarks, The World Convention of NA where it will be held in the following locations: 2013 WCNA 35 Philadelphia, PA; 2015 WCNA 36 Rio de Janeiro, Brazil; 2018 WCNA 37 North America; 2021 WCNA 38 Asia/Middle East/Africa; 2024 WCNA 39 North America; 2027 WCNA 40 Europe; 2030 WCNA 41 North America; 2033 WCNA 42 Central or South America.

There is a detailed report on Staff and Offices. Between July 2011 and June 2012 a total of 61 staff members were employed by NA World Services in four service centers around the world. Forty-eight of those employees worked in the Chatsworth office. Lastly in the NAWS Annual Report is the Financial Reports. These include the Consolidated Statement of Financial Position, Consolidated Statement of Activities, the Independent Auditor's Report, Investment in our Vision and, lastly, Regional Contributions. There were 12 total contributions from the Upper Rocky Mountain Region for \$778.72 which included none from the Regional Service Committee, one from our Area for \$140.00, and two from groups in our Area: Clean & Free made one for \$40.00 and Clean & Serene made one for \$35.00.
