### Regional Committee Member Report

February 12, 2017

Good afternoon,

I attended our RSC meeting last Saturday, February 4<sup>th</sup>, in Casper as the representative of this Area. The minutes for this RSC meeting should be available within a couple of weeks online at our regional website, <a href="www.urmrna.org">www.urmrna.org</a> under the service tab. There was a nice Workshop prior to the RSC that was conducted by Delynda H., our former Delegate, and Carla W., our Current Delegate, on "Social Media and Technology – Applying Our Principles" which was very interesting and very well done.

Sonny of Casper was elected as our new Regional Vice-Chair. Rob J. of Casper ran unopposed and was unanimously elected as our new AD (Alternate Delegate) while another long-term member, Ron of Gillette, was elected as the URMRCNA 19 Convention Chair, which the Freedom Seekers Area will host next year.

#### Wyo-Braska Area Service Committee Meeting Minutes - November 12, 2017

Meeting began at 2:05 pm with a moment of silence, followed by the serenity prayer. Twelve Traditions were read by Ryan, Twelve Concepts read by LaRea, and Twelve Values by Karen.

**Introductions:** Tommy O., RCM; Ryan C., GSR Clean and Free; Chris S., GSR Live From Laramie; Kyle C., Web servant; Aaron B., member; Devin W., Activities Coordinator; Dano M., GSR Clean and Serene; Joe A., GSRA Living Clean; Tina S., GSR Living Clean; Karen M., RCM2, GSR Life On Life's Terms; LaRea H., GSR Pine Bluffs NA

Recognition of new groups: Pine Bluffs NA, Pine Bluffs, WY; Living Clean in Sydney, Sydney, NE

**Opening Treasury balance:** \$688.83. Treasurer report emailed to Officers and GSRs. **Reports:** reading of August 2017 Minutes (*no Secretary so there were no August minutes to be read*)

RCM Report - Good afternoon, I attended our RSC meeting on Saturday, October 7<sup>th</sup>, in Gillette as the representative of this Area. Ending Regional Treasury balance was \$4321.62. Our Delegate reported on WCNA 37, Labor Day weekend 2018 in Orlando, Florida where registration is now open at the following web link - https://www.na.org/?ID=wcna-index. She also gave a financial report which included the Business Plan Group meeting of June that continued their work on the evaluation of NAWS literature distribution system. There were 800 responses from the literature survey, 200 of which reported they could not but literature locally. Additionally, more than 90% of all our literature orders come through online orders. The Business Plan Group gave the World Board three recommendations: one for a price increase, another for a return policy and a third for NA material on electronic tablets for correctional facilities. She also reported on STRATEGIC PLANNING via the ENVIRONMENTAL SCAN saying 66 regions provided input with two-thirds of those reporting a need to do better with relationships with the public, outside organizations, and professionals. Also included in her report was the ongoing Web Meetings: H&I. inmate step-writing, and Service in Rural and Isolated Areas, of which I have participated in most of the latter Web meetings. Your Alternate Delegate, our own Gail W., reported on the September 9th Conference Participants Webinar which dealt with the South Florida Regions request to look at NAWS financial records in conjunction with the literature price increase. It was very detailed, some twenty-two pages, which included some documents that were not to be released yet due to litigation. In brief, NAWS responded to the South Florida Regions request with some questions and that RSC had of yet responded back at the time of our RSC.

Our Area's Webpage, which Kyle reported on, has been included on our Agenda under both Old Business and Sharing Session. On the 20<sup>th</sup> of August I sent an email detailing Kyle's recommendation moving forward with the cost as the "deal" he reported to us required him to make a thirty-six-month commitment to receive the \$2.95 per month discount. It was Kyle's

recommendation that we move in this direction, I concurred, and the three return emails that came, from Brian, Karen, and Aubrey were all in favor meaning that, of the five members that responded all five (100%) were in favor. Since we do not, and have not, operated under "Robert's Rules of Order" for several years now and instead operate under "Consensus", I assumed Kyle would move forward and get the page back-up at this time. I emailed him asked how I could move forward with getting him a check to reimburse his expenses and received no repose until I inquired again the other day. He informed me that, along with his reasoning for not moving forward, that he was prepared to wait to get reimburse at the ASC.

As I have reported on our Area's Facebook page this Area has a "new" group, Pine Bluffs NA, which meets every Sunday at 2 pm in Pine Bluffs. I was very excited when a member of this group reached out to me as the RCM of this Area for help. I met with her a couple of times and got the group registered with NA World Services as a new group and purchased them a Group Starter Kit which I'll ask this ASC to cover that expense.

I would also like to recommend that this ASC make a Regional donation to the URMRSC as this is something we have not done for quite some time. You'll remember the Region basically gave us a donation while we were struggling to make ends meet due to both a lack of group donations and our Storage facility expense.
