





I imagine first, however, I will wait until we have a new H&I chairperson... or coordinator?

Speaking of chairpersons versus coordinators, the difference is namely the ways in which the service structure for each committee is organized and how labor is delegated. A <u>project based</u> service structure, which is led by appointed coordinators, are usually used if there isn't enough members to support a subcommittee to get specific projects done. Once those projects are completed, the committee dissolves (excluding the coordinator). A subcommittee is a structure with elected trusted servants that serve in whatever capacity for an agreed upon term. I don't mean to be a stickler, but I think for clarity and consistency for future members, it might be worthwhile to make our language consistent and to be clear about how, and for how long, our member serve in the positions for which we are drafting guidelines. I take no issue against the formulation of new committees for our Area, but I do care about consistency and clarity to support our current and future trusted servants.

I also want to mention that the reason I have been thinking about this is because, in <u>prepandemic</u> times, the Public Relations ad hoc was going to propose a subcommittee structure to Area and was developing service positions and guidelines *apart from* a project based service structure to support H&I and PI under the umbrella of PR.

I plan to reach out to the members I can recall having attended our ad hoc meetings for guidelines, etc. and move forward from there.
