WyoBraska Area Service Committee MTG Treasurer Report Prepared by Bailie A. Dec. 12, 2020 to Jan. 8, 2021 Hello NA family, I hope everyone had an enjoyable winter holiday season! This month was a full one. I completed the Audit requested at the last meeting which is attached in a different file. I finally received the card from Bank of the West just this week (the first one they sent got lost in transaction apparently, so I had to request another be sent after the holidays) and was able to submit our donation to NAWs, as well as pay our overdue phoneline bill through FreedomVoice. After having a bit more time to go through the bundle that was given to me by Karen of treasurer records, I would like to make a request to purchase a USB flash drive to keep all digital financial matters organized on. I would also like to request the purchase of an expanding file folder for organization of the paper documents. I believe this will be a huge benefit for future

incoming treasurers. From pricing research, a USB flash drive will be about \$10, and an expanding file folder will be about \$8, plus tax. I was able to talk to our banker, Zechary Gunther, and remove the monthly service fee of \$25 for lack of activity. As you will see in the Audit, that was adding up quickly. The title of our account is now an "Any Deposit Checking for Business" meaning we are only required to have a one deposit per month. If we fail to make a deposit, then a service fee of \$10 will be applied. We also eliminated the \$3 a month paper statement fee by going online. Since the bank only goes back 18 months for online banking, the plan will be to do as I did for the audit and download copies of the account summaries for our records. Unity Days 2021 was spectacular, truly. We all had a wonderful time fishing and eating the fabulous food Jason cooked and learning from each other. Our speakers were amazing, our workshops were productive, and (I can't stress this enough) the food was very yummy.

We had some hundreds of years of recovery in attendance, I think. We had around 40 people total at the height of the campout with three newcomers and a lot of love. I sent membership surveys home with folks; let me know if you have finished them! Area would love to hear your voices about how we are serving you.

Our traveling speakers were Yvette and Shawn, whom I ask that we reimburse. I will follow up with our events coordinator, Dave, to get receipts, etc. as I don't have a report. Wild Bill gave back our payment to use his land as a donation. I propose we gift him, at least, a hoodie as he requested one.

Our merchandise (and miscellaneous) report is as follows:

We ordered 20 t-shirts, 15 hoodies, and 100 stickers. I believe we have 3-4 t-shirts left, one hoodie and about 80 stickers. There has been more interest in

making another hoodie order. I can do that a^hytime but again we need to order at least 12 to get the group discount. I also received feedback about ways to improve the next unity days. It was suggested that we make it closer to our area, not necessarily a camp out, include speakers from our area and avoid frontier days. I feel it was a success and we had 35-40 people in attendance at our peak. I have recordings of Yvette and Shawn speaking, although my phone quit recording Shawn after an hour and I missed the last few minutes of his share.

Thanks for those suggestions, everyone. Considering these COVID years we have had, we held a pretty kick ass event. I know it will be even better next time!

I am acting treasurer, and I am terrible at math, which is why I don't take treasurer positions, but here goes:

We received \$730 in cash registration, merchandise, and 7th tradition

donations, which I deposited into my account to Venmo to Area (Bailie won't be here today and I am on Zoom so this is the best way to quickly get our treasurer the funds).

We received a \$150 donation via check from a member, which I also deposited into my account to Venmo to Area, the total reaching \$880 in cash/check payments.

We received \$320 in registration and merchandise purchases via Venmo, plus another \$55 from me, which I will Venmo with the rest of these funds today, for a total of \$375.

Together, then, we received \$1,255 in donations, registrations, and merchandise. I have the receipt for the cash deposit I made into my account and I venomed \$935 to Area this morning.

We budgeted \$200 for food, which Bailie venomed me prior to the event. However, between paper products, a propane tank, and emergency canopies, as well as deciding to cook two, instead of one, meal, our costs exceeded this amount.

Therefore, I am asking Area to reimburse me as follows:

An extra \$147.56 because our groceries totaled \$347.36 at Wal-Mart.

\$76.75 for ice and a propane tank at Loaf and Jug (by the way, Area now has a propane tank that we can use & refill as needed).

\$29.26 for paper products and silverware at the Dollar Tree.

Finally, \$23.97 for bottled water at Shell.

The total reimbursement equals \$277.54. (Images of receipts below). In sum, after reimbursement, we are left with \$978 total.

I don't know what our guidelines are on reimbursement for speakers for travel. We also feel that Shawn S. should be reimbursed for his RV campsite if possible since we didn't know Wild Bill's land was not hospitable to campers when we asked him to speak. All in all, it's been a wild ride and I am grateful to have served as a chair for this event! ILS,

The WSC participants have met consensus on the postponement of the WSC to 2023, with an interim conference in 2022 to be held virtually. The Interim conference will be held to fulfil our obligations to address legally essential business. That business is as follows:

NA World Services Budget for one year – 2022-2023

• Extend existing FIPT moratorium on inspection clause for one year. (Acting as the trustor, the delegates present at the virtual WSC 2022,

are continuing the suspension of Article 5, Section 3 of the *FIPT* Operational Rules, while we make a decision about the future. This suspension will expire at the close of WSC 2023.)

· Adjustment of terms for WSC trusted servants. (the details of this will be provided)

We will also be reviewing and approving the Spiritual Principles a Day draft.

There needs to be a discussion on how we would like to proceed with the material we will be covering in 2022. Since 3 of the items that will be discussed and voted on are essentially CAT (Conference Agenda Tract) items, and this region does not normally workshop CAT items, it would be up to this body to determine if we will workshop these items and hold the assembly to gather the consensus of the groups. In the past, the region has given the delegate team a vote of confidence regarding CAT items, meaning that the region has felt that the delegate team has enough information in order to be able to vote accordingly to the region's wishes.

- 1. Ask the regional body if they would like to continue as before, giving the delegate team a vote of confidence in these items and not workshop any of the material or assign time at the Assembly for the gathering of consensus on the CAT material. If there are no objections to giving the delegate team the vote of confidence, then we can proceed without workshopping any of the interim CAT content.
- Any literature coming from the conference needs to "Conference Approved" before it reaches the fellowship, conference approved means
 that delegates have brought the material to their members to review and vote on. This ensures that all of our literature is actually Fellowship
 approved, it is also a great privilege to be able to say that we were involved in the making of this new piece of literature so therefore the
 suggestion is that the SPAD draft is workshopped outside the interim CAR/CAT. The delegate team can put together a comprehensive
 workshop that RCM's can take back to their area's and GSR's, and we will assign time at the April Assembly to gather consensus.

We discussed absorbing Web Servant, but we want to bring up that whoever serves in this position currently has a vote at Area and will lose that vote if we take over the position as a subcommittee.

We received 3 phone calls between November 1 and December 11, 2021.

We are requesting a disbursement of \$30 to replenish our \$60 floating cash funds and \$72 to fund Jason's panel meeting materials if needed, for a total of \$102.

Ad Hoc Guidelines Committee Report 12-11-21

Third Concept

The NA groups delegate to the service structure the authority necessary to fulfill the responsibilities assigned to it.

We often use motions and guidelines to help us apply the Third Concept. We clearly describe each task we want accomplished, and the kind of authority we are delegating to those who will fulfill the task. However, even the most exhaustive set of guidelines cannot account for every eventuality. Our trusted servants will serve us best when we grant them the freedom to exercise their best judgment in fulfilling the responsibilities we've assigned them. Our services must remain directly accountable to those they serve, yet they must also be given a reasonable degree of discretion in fulfilling their duties. A group, service board, or committee should consult its collective conscience in arriving at its own understanding of the best way to apply this concept.

Hello WBASC!

Our first ad hoc meeting was on Sunday 12-05-21 at 10 AM and was very productive. We have decided to start at the beginning of the guidelines and work our way down through each section. We realize this will take some time and have decided that at each ASC we will present the proposals and areas that need addressed and request input from the ASC. We will make these changes as the ASC has given us their decisions on items we present. Doing this will ensure that when this project is completed, the entirety of the guidelines can be presented as a whole document. Below are the items we need input, votes and approval on. These changes are highlighted in blue.

SECTION 2 Purpose and Functions

1. For a new group to be eligible for inclusion in the WBASC, they are suggested to attend the meetings of the WBASC.

When more than one ASC servant can verify that a new meeting exists, they will be recognized as a new group in the minutes of the WBASC. At this first meeting the new group will be included on the (shared) Wyo-Braska Area meeting list and they will be listed on the telephone information line of the WBASC and the Wyo-Braska Area Webpage. It is suggested this new group give a verbal report and turn in a written report to the WBASC secretary for inclusion in the minutes

Change to:

For a new group to be eligible for inclusion in the WBASC, their representative must attend the monthly meetings of the WBASC. At the first meeting they attend, they will be recognized as a new group in the minutes of the WBASC. At this first meeting the new group will be included on the (shared) Wyo-Braska Area meeting list and they will be listed on the telephone information line of the WBASC. This new group will give a verbal report and turn in a written report to the WBASC secretary for inclusion in the minutes. After attending 2 (two) WBASC consecutive monthly meetings, this new group is then considered a full member in good standing at the WBASC with all the inherent rights and privileges therein.

After no representation in 3 months, the group will be taken off the roll call (agenda), they will remain on the meeting list, until the meeting can be verified that it does not meet or has been closed. If the meeting is closed it will be removed from the meeting list immediately. SECTION 8 Duties of Administrative Committee Officers

1. Regional Committee Members (RCMs)

The two (2) RCMs are the WBASC's representatives at the regional level. The RCMs link the WBASC with other area service committees within the Upper Rocky Mountain Region. The primary responsibility of the RCMs is to work for the good of the WBASC, providing two-way communication between the WBASC and the rest of NA. They represent the WBASC groups' consciences at the regional level.

The RCMs attend all WBASC and all URMRSC meetings. They take part in any discussions and in all decisions affecting the region, speaking as the voice of the WBASC groups' consciences. It is suggested that the RCM(s) have a minimum of three (3) years clean time, has demonstrated a working knowledge of the Twelve Traditions and the Twelve Concepts for NA Service, and presents a history of completed NA service positions, preferably at the group and area level. It is the duty of the RCM(s) to:

- 1. Represent the interests of the WBASC at the URMRSC and to carry the WBASC's groups consciences and work for the primary purpose of NA
- 2. Report to the WBASC verbally and in writing the activities of the URMRSC
- 3. Report to the URMRSC verbally and in writing the activities of the WBASC
- 4. Submit a written report of activities as RCM and a copy of the information submitted to the URMRSC at each WBASC meeting report needs to be presented to area before submission to region voted in 11/20/21 Should this be topics need to be discussed at area before reporting to region? Would like another discussion on this Proposal
- 5. Attend all WBASC meetings, URMRSC meetings and Upper Rocky Mountain Regional Assemblies
- 6. Reimburse travel expenses to regional meetings and assemblies at .30 cents per mile
- 7. Will be signers on the WBASC bank account
- 8. Will each serve one two-year cycle, with the option of serving two two-year cycles, thus committing to up to eight years and four cycles in total

9. The "second" RCM is basically "in training" for a two-year term and will assume all tasks and responsibilities of the first RCM at the completion of the two-year cycle

WYO-BRASKA AREA SERVICE COMMITTEE OF NARCOTICS ANONYMOUS

SECTION 1 Name and Boundaries

The name of this committee is the Wyo-Braska Area Service Committee (hereafter referred to as WBASC) of Narcotics Anonymous (hereafter referred to as NA). This committee will service and include any and all interested Narcotics Anonymous Groups in Southeast Wyoming and in the Nebraska Panhandle.

The WBASC, in accordance with NA's 7th Concept, is an open participation forum which allows all interested NA members to participate in the process.

The WBASC also serves as a link between the NA groups of the Wyo-Braska Area and the Upper Rocky Mountain Regional Service Committee (hereafter referred to as the URMRSC) of NA. And, the WBASC shall be registered with the Narcotics Anonymous World Services, Inc. (hereafter referred to as NAWS).

SECTION 2 Purpose and Functions

The purpose of the WBASC is to support the Wyo-Braska Area Groups in fulfilling their primary purpose by providing those services and Standing Sub-Committees as deemed necessary by the groups. In the words of NA's Ninth Tradition, they "create service boards or committees directly responsible to those they serve". In all its proceedings, the WBASC shall adhere to the Twelve Traditions and Twelve Concepts of Service of NA. The WBASC is directly responsible to the groups it serves.

The WBASC is intended to foster unity and the common welfare of its member groups. Common welfare should come first; personal recovery depends on NA unity.

An NA group is described as follows in the "A Guide To Local Services in Narcotics Anonymous"; when two or more addicts come together to help each other stay clean, they may form a Narcotics Anonymous group. Here are six points based on our traditions which describe an NA group:

- All members of a group are drug addicts, and all drug addicts are eligible for membership.
- As a group, they are self-supporting.

- As a group, their single goal is to help drug addicts recover through application of the Twelve Steps of Narcotics Anonymous.
- As a group, they have no affiliation outside Narcotics Anonymous.
- As a group, they express no opinion on outside issues.
- As a group, their public relations policy is based on attraction rather than promotion.

An NA group is any meeting which meets regularly at a specific place and time, and which follows the Twelve Traditions of NA. The primary purpose of an NA group is to carry the message of recovery to the addict who still suffers. For a new group to be eligible for inclusion in the WBASC, they are suggested to attend the meetings of the WBASC.

For a new group to be eligible for inclusion in the WBASC, their representative mustattend the monthly meetings of the WBASC. At the first meeting they attend, they will be recognized as a new group in the minutes of the WBASC. At this first meeting the new group will be included on the (shared) Wyo-Braska Area meeting list and they will be listed on the telephone information line of the WBASC. This new group will give a verbal report and turn in a written report to the WBASC secretary for inclusion in the minutes. After attending 2 (two) WBASC consecutive monthly meetings, this new group is then considered a full member in good standing at the WBASC with all the inherent rights and privileges therein.

After no representation in 3 months, the group will be taken off the roll call (agenda), they will remain on the meeting list, until the meeting can be verified that it does not meet or has been closed. If the meeting is closed it will be removed from the meeting list immediately. If the group returns to area, after being removed from the roll call and meeting list, they will need to follow the guidelines for a new group. (12/11/21)

The WBASC is comprised of Group Service Representatives (hereafter referred to as GSR), GSR Alternates, the Administrative Committee (consisting of the Chair, Vice Chair, Secretary, Treasurer, and two RCMs), Standing Sub-Committee Chairs, Ad Hoc Committees, and any interested addicts from the Wyo-Braska Area or elsewhere. The WBASC shall maintain a P.O. Box address, a bank account, an Information Phoneline and a web presence which will include the web page www.wyobraskana.org.

The WBASC will conduct an area inventory each year, to be conducted by the PR Sub-Committee. The inventory will be sent out to the fellowship each July and will be due by August, the PR committee will submit the results of the survey at the September ASC. (12/11/21)

The WBASC shall donate all monies above its working prudent reserve to the URMRSC and to NAWS (Narcotics Anonymous World Services). To ensure monetary security of the WBASC, no two (2) signers on the bank account of this area may reside in the same household.

SECTION 3 Meetings

The regular meeting of the WBASC is held every month on the second Saturday at 12:00 pm. All WBASC meetings are non-smoking. The ASC will rotate business meetings between towns currently being served by the WBASC (Laramie, WY; Scottsbluff, NE; or any location) determined by the ASC itself, A virtual option will be made available for those members who are unable to attend in person, virtual meetings will be recorded. There will be no calls for a vote outside the scheduled ASC meetings, unless an officer of the WBASC requests an emergency meeting to address any urgent issues. These emergency meetings will be held virtually. (12/11/21)

SECTION 4 Members

The Seventh Concept for NA Service says, "All members of a service body bear substantial responsibility for that body's decisions and should be allowed to fully participate in its decision making-processes." It is for this purpose that all attending members of the WBASC, providing they are clean, will have the right to enter discussion and/or debate, introduce proposals. These proposals will be subject to process used in the Consensus Based Decision Making process.

Voting members are comprised of committee members and GSR's. Money matters will be voted on within the business meeting, all other matters should be taken back to the groups for vote to be decided at the next scheduled ASC. To be voted on at the end of the project.

The WBASC shall follow the guidelines set forth in the Twelve Concepts for NA Service and A Guide to Local Services in Narcotics Anonymous. All WBASC business meetings shall be open to any member of Narcotics Anonymous but shall be closed to the general public.

SECTION 5 Officers

The Administrative Committee Officers of the WBASC are the Chair, Vice Chair, Secretary, Treasurer, and the two (2) Regional Committee Members (hereafter referred to as RCMs). These individuals are responsible for administrating the general affairs of the entire area committee. Because of that, it is important that great care be taken in their selection. A substantial amount of clean time and personal maturity should be the first consideration, along with experience with the 12 Steps, 12 Traditions, and 12 Concepts of Service. The officers shall be elected by the voting members present. The term of office starts when elected and lasts two years in length.

SECTION 6 Vacancy / Removal of Officers

The WBASC may declare vacant the office of any elected officer who has been:

- Absent at two (2) consecutive WBASC meetings without contact, representation, or report.
- Found unable, by the committee, to perform their duty to the position.
- Fails to meet requirements and duties as described in SECTIONS 7 and 8 of these guidelines.
- Fails to stay clean and in recovery during their term.

SECTION 8 Duties of Administrative Committee Officers

In addition to the requirements listed below, officers shall have the following:

1. Willingness and desire to serve

2. Personal time and ability to serve

3. Knowledge of the Twelve Steps, Twelve Traditions and Twelve Concepts of Service for NA

4. Continued abstinence during term of office

5. waiving clean time

Chairperson

The chairperson presides over the WBASC meeting and must show the ability to chair in a firm and understanding manner. At the WBASC meetings, the chairperson can only vote in the case of a tie on WBASC business. It is suggested that in the case of a tie, since a clear path for the fellowship group conscience is not there, the chairperson solicits minority opinion if applicable or tables the motion to the next regular meeting of the WBASC. This will give the groups time to clarify their vote and needs. It is suggested that the WBASC chairperson have a minimum of three (3) years continuous clean time, has demonstrated a working knowledge of the Twelve Traditions and the Twelve Concepts for NA Service, and presents a history of completed NA service positions, preferably at the area level.

It is the duty of the WBASC chairperson to:

- Open the meeting
- Recognize members or observers who are entitled to the floor

Vice-Chairperson

It is suggested that the WBASC vice-chairperson have a minimum of two (2) years continuous clean time, has demonstrated a working knowledge of the Twelve Traditions and the Twelve Concepts for NA Service, and presents a history of completed NA service positions, preferably at the area level.

It is the duty of the WBASC vice-chairperson to:

- Temporarily serve as the chairperson in the absence of the chairperson
- Be one of the signers on the WBASC bank account
- To temporarily serve as chair of a standing subcommittee in the absence of the chair and vice-chair of said committee
- To oversee all standing subcommittees
- Attend or obtain a verbal report from each monthly standing subcommittee meeting prior to the regular WBASC
- Submit a written report of monthly activities as vice-chairperson at each WBASC
- Assist the chairperson in any duties as may be mutually agreed upon, learning from the chairperson those duties inherent in that position
- Attend every regular WBASC meeting
- Will work with the RCM2 to assure that the duties of any vacant position at WBASC are performed

Secretary

The Secretary keeps accurate minutes of each WBASC business meeting, types and distributes copies to each member no later than two (2) weeks after the WBASC meeting. The Secretary is also responsible for maintaining the WBASC archives. It is suggested that the WBASC Secretary have a minimum of eighteen (18) months continuous clean time, has demonstrated a working

It is the duty of the WBASC Secretary to:

- Keep accurate records of all the proceedings of the WBASC
- Keep on file all GSR and Standing Sub-Committee reports
- Keep the WBASC official GSR /Administrative Committee/Standing Sub-Committee Chair roll and calls the roll when it is required
- Make the minutes and records available to members upon request
- Furnish committees with required literature and forms for the performance of their committees.

Treasurer

The Treasurer will make a report of all the contributions and expenditures at every WBASC meeting as well as an end of term(s) of office report. It is suggested that the WBASC Treasurer have a minimum of three (3) years continuous clean time, has demonstrated a working knowledge of the Twelve Traditions and the Twelve Concepts for NA Service, and presents a history of completed NA service positions, preferably at the area level.

It is the duty of the WBASC Treasurer to:

- Be the custodian of the WBASC funds
- Maintain a comprehensive ledger that records all transactions and budgets
- Be one of the signers on the WBASC bank account
- Report income and disbursements at each regular WBASC meeting, followed by a written report in the minutes
- All reports should include a reconciling to the bank statement and a copy of that month's statement
- Disburse funds as directed by the WBASC
- All disbursements must be in check format for tracking purposes
- All persons requesting reimbursements which have been approved must submit receipts

Regional Committee Members (RCMs)

The two (2) RCMs are the WBASC's representatives at the regional level. The RCMs link the WBASC with other area service committees within the Upper Rocky Mountain Region. The primary responsibility of the RCMs is to work for the good of the WBASC, providing two-way communication between the WBASC and the rest of NA. They represent the WBASC groups' consciences at the regional level.

The RCMs attend all WBASC and all URMRSC meetings. They take part in any discussions and in all decisions affecting the region, speaking as the voice of the WBASC groups' consciences. It is suggested that the RCM(s) have a minimum of three (3) years clean time, has demonstrated a working knowledge of the Twelve Traditions and the Twelve Concepts for NA Service, and presents a history of completed NA service positions, preferably at the group and area level.

It is the duty of the RCM(s) to:

- Represent the interests of the WBASC at the URMRSC and to carry the WBASC's groups consciences and work for the primary purpose of NA
- Report to the WBASC verbally and in writing the activities of the URMRSC
- Report to the URMRSC verbally and in writing the activities of the WBASC
- Submit a written report of activities of area as RCM and a copy of the information submitted to the URMRSC at the following WBASC meeting Topics sent to region need to be discussed at area before reporting to region (12/11/21).
- Attend all WBASC meetings, URMRSC meetings and Upper Rocky Mountain Regional Assemblies
